

# NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.038875 per \$100 valuation has been proposed by the governing body of Harris County Emergency Service District 9.

PROPOSED TAX RATE	\$0.038875 per \$100
NO-NEW-REVENUE TAX RATE	\$0.038831 per \$100
VOTER-APPROVAL TAX RATE	\$0.051140 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Harris County Emergency Service District 9 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Harris County Emergency Service District 9 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Harris County Emergency Service District 9 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 25, 2025 AT 6:00PM AT 10710 Telge Road Houston, TX 77095.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Harris County Emergency Service District 9 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of Harris County Emergency Service District 9 at their offices or by attending the public hearing mentioned above.

AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$
